**Sub:- Letter No:-3-47/2014-B&CS (Complaint Against M/s Fastway
Transmission Pvt. Ltd.)**

Respected Sir,

The undersigned have received letter dated 11th June 2014 from this office along with copy of reply being submitted by M/s Fastway Transmission Pvt. Limited.

We intends to submit that the reply being filed by M/s Fastway Transmission Pvt. Limited is based upon bundle of lies the same has been filed to save the skin of the company from legal consequences, the company has annexed copy of agreement which was executed in year 2012 with one Sukhdev Singh Prop of K.K.Cable Tv of Ludhiana, the same is no where concerned with us. The Cable operators of Amritsar executed agreement in Janaury 2014, the copy of same agreements have neither been provided to the Members of Sangarsh Committee nor the same have been provided to TRAI to verify the authenticity of agreement,

it clearly indicates that the company not only harassing the cable operators of Amritsar but also misleading TRAI by placing on record wrong documents, the act the company requires strict legal action against the company who put on stake necessary mandates of TRAI for personal benefits.

The Company has categorically taken a plea of gross billing, it has been blamed that the operators are refusing to pay gross billing.

we intends to submit here that the policy of the Company is not transparent, the company intends to suck the blood from the bones of the Cable operators on the pretext of gross billing, LCO of Amritsar have been regularly paying share of the Company and this fact has also been admitted in para no 4 of the reply being submitted by the Company.

The LCO have been paying Rs. 65+35 =Rs.100/- per STB to the Company and also paying Tax Rs. 14/- to the government regularly, without any delay, so per box is casting Rs. 114/- to the LCO. The Company has been Scrolling a message to the viewers the same is as under:-

Rs. 230/-for 1st STB & Rs. 130/- for 2nd & 3rd

For per house this method is applicable for every LCO in Amritsar while collecting money from the viewers but the cost of LCO is Rs. 114 for per STB & there is no difference of payment for 1st, 2nd & 3rd STB while making payments to the Company. The LCO number of time requested to the Company to provide some relaxation to the LCO for making payment of 2nd & 3rd STB for the same house, as the LCO are also bearing expenses for maintaining their offices, Cable Lines, implements & labor expenses and the cost of the same have been increasing day by day but the company is not ready to listen even a single word in this regard

rather openly passing threatening for disconnection of cable signals if refused to meet unjustified demands of the Company.

Para wise comments on reply are as under:-

1. That we deny the submission as detailed in para no 1 of the reply, the company has never provided copy of agreements executed in January 2014 to the Members of Sangarsh Committee, more over the company has annexed copy of agreement which was executed in year 2012 with one Sukhdev Singh Prop of K.K.Cable Tv of Ludhiana, the same is no where concerned with us.

2. That we deny the submission as detailed in para no 2 of the reply, the company has never provided copy of agreements executed in January 2014 demands were made by the members of Sangarsh Committee for getting the copies of agreements but the same not responded by the Company consequent to that the members of Sangarsh Committee held a meeting on 1-2-2014 in presence of press, news in this regard was published in various news papers on 2-2-2014, copies of News cutting are annexed.

3. That we deny the submission as detailed in para no 3 of the reply, the leaders of Sangarsh committee have been falsely implicated by Mr. Sarbjit Singh @ Raju in order to suppress the voice of the cable operators who raised their voice to protect their rights, the members of Sangarsh Committee never fired any shot as alleged in the FIR by Mr. Sarbjit Singh @ Raju, this fact can be well verified from the Video Clipping meeting, when the meeting was in process then the video cameras being affixed by Mr. Sarbjit Singh @ Raju were regularly taking photographs of every event, so the Company be directed to place on record relevant CD to verify the ground realities, these prove are sufficient to show the highhandedness of M/s Fastway Transmission Pvt. Ltd as well as Mr.

Sarbjit Singh @ Raju who left no stone unturned to create terror in the meeting in fact the fires were shot by the supporters of Mr. Sarbjit Singh @ Raju to create panic during the meeting.

The leaders of Sangarsh Committee granted interim bail by the Court of Sh. Jasvir Singh Kang Additional Session Judge, Amritsar and the same Anticipatory Bail was confirmed by the Court of Sh. Surinder Singh Sahni Additional Session Judge, Amritsar, copies of the order are attached.

4. That we deny the submission as detailed in para no 4 of the reply, it has already been submitted that in the earlier paras that the policy of the Company is not transparent, the company is not co-operating with the LCO for solving their problems rather forcing the LCO to make the payments to the company as per the dictates of the company without raising any objection otherwise their connections would be disband by the company, the LCO are bound to follow the dictates of the Company to protect their business, Company has been receiving shares from the LCO, this fact is admitted by the company so the company cannot take plea for gross billing.

Company be directed to solve the problems of LCO as per ground realities, provide relaxation to the LCO for making payment of 2nd & 3rd STB for per house as every viewer has installed 2 to 3 STB in house and they have been making payment to the LCO as per Scroll of the Company as detailed above in the earlier paras.

5. That we deny the submission as detailed in para no 5 of the reply, it is hereby submitted that Mrs. Roop Sharma is a well known figure, she being president of Cable Operator Federation of India always raised her voice against those companies who overlooked the problems of the LCO

and forced the LCO to meet with in-genuine demands of the Companies.

The Members of Sangarsh committee is also members of Cable Operator Federation of India and they are morally & duty bound to co-operate Mrs. Roop Sharma unconditionally.

The Company be directed to focus on the problems of LCO instead of foxing the activates of Cable Operator Federation of India, because if the Company will solve the problems of LCO then no one lodges any complaint against the Company, the administrators of the Company be directed to make a transparent policy for smooth running of cable business.

We have already submitted in the earlier paras regarding the problems of LCO, we humbly requests your good-self to pass appropriate directions to the Company to save & protect the members of Sangarsh Committee.
